### TRANSACTION IN OWN SHARES

Alpha Real Trust announces that on 14 September 2021 it purchased 12,500 ordinary shares of no par value (“Ordinary Shares”) at a price (before expenses) of 164.0 pence per share. The purchased shares will be held in treasury.

The total number of ordinary shares of the Company (including treasury shares) following the purchase is 63,339,628. The Company holds 2,122,924 shares in treasury. The total voting rights of the Company following the purchase is 61,216,704.
